## **Terms and Conditions**

In the event that this Credit Facility is approved by Northside Truck & Van Ltd, the buyer, unless otherwise herein provided acknowledges and agrees with Northside Truck & Van Ltd that:

- Unless otherwise nominated by Northside Truck & Van Ltd, the buyer shall make payment for all goods ordered/purchased or services within 30 days. The buyer also understands that these terms are the normal trading terms of Northside Truck & Van Ltd.
- The costs of collection of any monies then due and owing, including but not exclusively, the fees of any mercantile agent or solicitor engaged by Northside Truck & Van Ltd shall be recoverable in full against the buyer.
- If at anytime monies are overdue and owing upon any invoice then outstanding, the whole of the amount of all invoices then outstanding shall become immediately due and owing.
- The buyer acknowledges that the credit facility and account number provided to the buyer are personal to the buyer and shall not be assigned, transferred or made available by the buyer for use by any other corporation, person or organisation and further acknowledges that any goods ordered/purchased or services rendered under the credit facility or account number shall be paid by the buyer.
- Northside Truck & Van Ltd may from time to time nominate or vary the buyer's maximum credit facility.
- It is the buyer's responsibility to notify Northside Truck & Van Ltd of any or any intended change in the corporate structure, shareholding or management by written notice within 30 days of such event occurring.
- Northside Truck & Van Ltd may at any time without notice terminate or suspend the buyer's right to purchase goods and obtain services upon credit.
- If the information supplied by the buyer in the confidential credit facility application is found to be misleading or erroneous, or should the buyer fail to comply with the conditions of this confidential credit facility application or the trading terms, Northside Truck & Van Ltd may at its absolute discretion cancel the credit facility and refuse to supply further goods to the buyer, including any goods subject to an order accepted by Northside Truck & Van Ltd but not delivered prior to the date of exercising such discretion and further that Northside Truck & Van Ltd shall not be liable to the buyer for any loss or damage which the buyer may sustain as a result of Northside Truck & Van Ltd cancelling the credit facility or refusing to supply the goods.
- Any work done or goods supplied in relation to a vehicle, by the order of any driver in the buyer's employ, or by any person who is reasonably believed to be acting as the buyer's agent, or by the order of any person to whom Northside Truck & Van Ltd is entitled to make delivery of the vehicle, shall be paid for by the buyer.
- Payment for all repairs and/or spare parts supplied is due on completion of work, but Northside Truck & Van Ltd may demand a deposit before commencing or in the course of any work. A repair is completed for the purpose of these conditions when notice has been given that the vehicle is ready for collection.
- Northside Truck & Van Ltd shall have a general lien on a vehicle and all its contents for all monies owing to Northside Truck & Van Ltd by the buyer on any account whatsoever. Northside Truck & Van Ltd shall be entitled to charge garage rent during any period in which the vehicle is retained by virtue of the lien.
- All parts removed by Northside Truck & Van Ltd in the course of repair shall, if not claimed by the buyer within 14 days after the completion of the repair, be deemed to be wholly abandoned to Northside Truck & Van Ltd and they shall become Northside Truck and Van Ltd's absolute property accordingly.
- Any notice to the buyer posted to his last known address shall be good notice.
- No alteration or qualification of these printed terms and conditions shall be effective unless in writing, signed on behalf of Northside Truck & Van Ltd by a director or a duly authorised officer of Northside Truck & Van Ltd. No other person has any authority to alter or qualify in any way the above printed conditions or to enter into any contract for repair for any of the purposes set out in the preamble above on behalf of Northside Truck & Van Ltd otherwise than on such conditions.
- All goods remain the property of the vendor until payment is made in full and any relevant cheques are cleared. Risk passes on delivery. Cheques will be accepted to the limit authorised by the banker's card.
