## NFU Land Rover offer

### Terms and Conditions

1. This programme is available to NFU Farmer and Grower, NFU Partner and NFU Retired members only, which meet the following criteria:  
If started NFU membership BEFORE 1<sup>st</sup> June 2015:
  - i. Be an NFU Farmer and Grower member, Partner (provided they are linked to an F&G record) or Retired member;
  - ii. Have maintained over 3 months of continuous membership at point of request, and
  - iii. Have a Direct Debit instruction set up for the current membership year or have paid in full for the current membership year at the point of request, subject to NFU discretion, if a cash payer.  
If started NFU membership ON or AFTER 1<sup>st</sup> June 2015:
  - i. Have maintained 26 months of continuous membership at point of request, and
  - ii. Have made a minimum of 2 years subscription payment with a Direct Debit instruction set up for the current membership year if paying by Direct Debit or have made a minimum of 2 years subscription payment and in addition, have paid in full for the current membership year at the point of request, subject to NFU discretion, if a cash payer.
  - iii. In addition, NFU Partner memberships must be linked to a valid NFU Farmer & Grower membership to be eligible.
2. This programme is not available to any other NFU membership categories or any member that does not meet the eligibility criteria, as set out in Point 1.
3. Eligible members are allowed a maximum of 2 vehicle vouchers per membership year (1<sup>st</sup> November – 31<sup>st</sup> October). This applies across all NFU vehicle partners and is not per manufacturer. However, requests for additional volume will be considered on an exceptional basis.
4. A voucher is valid for 30 days and must be presented to an authorised Land Rover dealer at the point at which you order the vehicle and this must be before the expiry date shown.
5. A voucher is invalid if:
  - i. The name and address on the voucher does not match the name and address on the dealer invoice, or
  - ii. It is presented to an authorised Land Rover dealer after the expiry date.
6. This programme is a stand alone offer from Land Rover, it cannot be used in conjunction with any other Land Rover support programmes, e.g. sub vented finance or loyalty programmes.
7. Members should advise their dealer that they intend utilising the 'NFU / Land Rover Affinity' programme at the commencement of their discussions.
8. The additional support from Land Rover is over and above that negotiated by members with their supplying dealer. The support is off the list price excluding VAT and the supplying dealer will claim the additional support direct from Land Rover, thereby providing net invoicing.
9. The support is only for new vehicles purchased direct from a Land Rover franchise holder within the United Kingdom and does not apply to any:
  - a) Used or Pre-Registered Vehicles;
  - b) Special Editions Vehicles, or
  - c) Special Vehicle (SV) conversions, option packs or pricing as advertised by Land Rover, e.g. tipper, the support will only apply to the donor vehicle not the conversion element.
10. Vehicles purchased under this programme must be retained for a minimum of 12 months before resale.
11. The NFU or Land Rover may change the terms and conditions, including the availability of the deal at any time and without notice.
